

## JACOBSTOW PARISH COUNCIL

Minutes of Meeting held on 3<sup>rd</sup> November, 2015

- 1) **Attendance** - Cllr. Norman Osborne chaired the monthly meeting of the Parish Council with Cllrs. C Smith, R Reason, D Adey, R Fox, I Franklyn, County Cllr. Nicky Chopak and two members of the public in attendance. Apologies received from Cllr. P Chapman.
- 2) **Declaration of Interest/Dispensation** - There were no declaration of Interest/Dispensation in respect of items on this Agenda.
- 3) **Minutes** – The minutes of the previous meeting were read and signed as correct.
- 4) **Canworthy Water Solar Farm** - Thanks were expressed to Cllr. Nicky Chopak for all her hard work in helping to negotiate the community benefits for the four parishes from Primrose Solar the current owners of the Canworthy Water Solar Farm. Decided a committee should be formed to discuss ideas on how the money should be spent.
- 5) **Paperless Planning** - It was noted that the grant of £700 had been received from Cornwall Council to cover the extra costs involved to deal with the paperless planning.
- 6) **Neighbourhood Planning** - A note to be put in the next Jacobstow Journal asking people to look at the Parish Plan to see if any changes need to be made.
- 7) **ACTIVE PLUS** - Active Plus Communities is a 4 year fully funded project that will encourage and support older people to become active in their communities. This will take place in the Parkhouse Centre on Wednesdays 9.30. – 12.30pm.
- 8) **Precept** - The Precept for 2016/17 was discussed and it was decided to ask for £4,000 this year. Proposed Cllr. Adey, Seconded Cllr. R Reason and unanimously agreed.
- 9) **Pay Clerk** - It was agreed to pay the Clerk her salary amounting to £440.00 plus expenses £69.76 Total £509.76 Proposed Cllr. Smith, seconded Cllr. Reason.

**10) Parish Hall Acoustics** - Letter received from Mr Mike Quance regarding the acoustics in the Parish Hall. This was discussed and the letter passed to the Hall committee as necessary.

**11) Road Closure** - Cornwall County Council advised that the road from Hallworthy to Kennards House the A395 will be closed for repairs from 2<sup>nd</sup> – 6<sup>th</sup> November, 2015. This will be 24hrs per day.

**12) Balance** – It was noted that the balance at the bank is £15,659.93.

**13) The Planning Inspectorate – Appeal Decision – Sudcott Farm, Week St Mary** - The appeal is dismissed. The planning obligation dated 28<sup>th</sup> June, 2002 between North Cornwall District Council and Richard Gilbert Coulter Hancock shall continue to have effect.

**14) Pot Holes** – Cllr. Nicky Chopak reported that Cormac will be patching the worst (Category one) pot holes within the next couple of weeks.

There being no further business the meeting was closed.
